ENTRY REQUIREMENTS

There are no formal education entry requirements for this course; however successful enrolment into this course will require that you:

- Can deal with physical demands of manual tasks (e.g. bending, squatting, kneeling, and repetitive movements, carrying) for direct support work during Vocational Placement and have the ability to be on your feet for extended periods of time, both walking and standing due to the nature of the occupation.

COURSE DELIVERY AND DURATION

All training is delivered online via our eLearning platform and Zoom. You will need to have access to a computer and reliable internet access.

This course is delivered two days per week for 16 weeks from 9.30 am to 3.30 pm, with an additional three hours dedicated for completing practical role plays and a recommendation of 10 hours' self-study at home to complete the required work.

This course is made up of 18 units of competency including seven core units and eleven elective units which include five ageing units, five disability units and one shared unit.
